

# NOTIFICATION OF RETIREMENT



Under GAR 106(3): The LAST REGISTERED OWNER of the greyhound must notify the Controlling Body (GRNSW) by lodging the prescribed form:

- Within **ten (10) working days** if the greyhound has been retired as a pet, been transferred to an adoption program, exported or surrendered to another agency
- Within **two (2) working days** if the greyhound has been humanely euthanased by a veterinary surgeon or is deceased
