

NOTIFICATION OF INTENTION TO TRANSFER A REGISTERED GREYHOUND

THIS FORM MUST BE COMPLETED BY THE OWNER OF A REGISTERED GREYHOUND PRIOR TO A TRANSFER. A REGISTERED GREYHOUND INCLUDES BOTH NAMED AND UN-NAMED GREYHOUNDS.

Greyhound Racing Prohibition Act 2016

Greyhound authority to be notified of transfer of greyhound

The owner of a registered greyhound must notify Greyhound Racing NSW in writing before transferring the greyhound:

- (a) to any other person who is registered as a greyhound owner under the greyhound racing rules or under the law of any other State or Territory, or***
- (b) to a person or body conducting a greyhound adoption program.***

Maximum Penalty: 10 penalty units (currently \$1100)

Note: A greyhound adoption program means a program conducted in accordance with a protocol approved by the Royal Society for the Prevention of Cruelty to Animals (RSPCA) NSW, or the Animal Welfare League (AWL) NSW, and includes the RSPCA and AWL in NSW.
