

REQUEST FOR GRNSW CONSENT TO RETIRE, EXPORT, TRANSFER OR DESTROY GREYHOUND

Greyhound Racing Regulation 2016:

The owner of a registered greyhound must not, except with the written consent of GRNSW:

- (a) retire the greyhound from racing, or
- (b) export the greyhound to a country other than Australia, or
- (c) transfer the greyhound to a person who is not registered as a greyhound owner under the rules or under the law of any other State or Territory, or
- (d) destroy the greyhound or cause it to be destroyed.

Note: you do not require GRNSW consent to transfer your greyhound to a person who is registered as a greyhound owner under the GRNSW Greyhound Racing Rules or under the law of any other State or Territory, or to RSPCA NSW. However you **must notify** GRNSW in writing of the relevant details of such a transfer prior to it taking place.

4. REQUEST FOR GRNSW CONSENT TO HAVE THE GREYHOUND DESTROYED

GRNSW strongly encourages all owners to attempt to retire their greyhounds as pets either to themselves, to a rehoming provider or to a third party. Any request for consent to euthanase a healthy greyhound will need to provide justification of why the greyhound could not be retired as a pet.

Greyhounds may only be destroyed via humane euthanasia by a veterinarian
